Rochelle and her team help consumers with debt negotiation and settlement, and in resolving credit reporting issues through targeted credit repair and credit counseling. The firm also practices in Fair Credit Reporting Act and Fair Debt Collection Practices Act litigation. Her firm is at the forefront of helping consumers recover from financially traumatic events like bankruptcy, distressed property situations, divorce, and unemployment.

Rochelle believes in educating society about credit and debt basics and she has been a panelist for several finance clinics discussing credit reporting issues in mortgage lending, including for the Arizona School of Real Estate and First American Title. She has chaired and coordinated a continuing legal education seminar on credit and debt issues for real estate, family, and bankruptcy law attorneys hosted by the Sandra Day O'Connor College of Law at ASU. Rochelle also volunteers her time to organizations like the Phoenix YWCA to teach financial literacy.

Rochelle has also had several radio appearances, including Candid Conversations, Wise Counsel on 1100 KFNX, In the Know with Tom Diller on KQCK, and The Straight Scoop with Chadwick Burks on 960 The Patriot.
